a. Hyacinth Place – Fence and Property Information

- -Fence damaged in car accident. Work to begin in spring. Lot has 15 spaces and 1 ADA space.
- -Will try to narrow curb cut to driveway to allow for more street parking.
- -Lot permitted for building residents only.
- Considering installing bollards on Hamlet and along Blvd. in case of another crash, would be safer. Shrubs and trees included in landscaping.
- Fence will be more visible from inside parking lot and will be screened by shrubbery from the outside.
- -Scaffolding is for chimney pointing. Scaffolding will be coming down in a couple of weeks.

Why is zoning changes attached to a grocery store?

- Pitt has 2 sites within an area that Walnut Cap has proposed to rezone. Just like UPMC has sites within that area. Grocery would benefit all. Site will be developed by Walnut Cap. They were chosen long ago to develop the site. They also own property nearby which causes confusion. A major grocer requires certain residential base. Requiring density. If you cannot increase density that makes grocers nervous.

How will you rent to non-students?

- Partner with a developer to gear in a way to discourage non student residents. Employer assisted housing. (Walk to work – an Oakland wide program. Across housing types. Across income levels.) Program is developing and will share more details as available.

Liz - DPW hired 2 enforcement officers. Renter registration is set to take effect – May 22nd. Any houses built before 1974 will be required to have lead testing done to be a rental.

b. Neighborhood Plan for Oakland

Derek Dauphin - Manager, Dept of City Planning

- Zoning will be permanent.
- Neighborhood benefits: Pedestrian improvements on Blvd. Trees, bus stop improvements, Oakcliffe Greenway as priority, Hillside above Bates- stabilize, plant natives, trails, storm water management.. Shared shuttle and transit study. Affordable housing.

Where does this money come from for the above ideas?

 Various sources depending on specific project. City capital budget matched with a grant often environmental and open space projects, Storm water management dollars, Penn Dot and other agencies. Plan to understand need then use that to find funds. Projects are important to community.

185 ft high rise is possible on Isalys site. Site is adjacent to 2 streets of 2 story houses. (With points) 185 ft is max with points that would need to be earned. Site topography is high. We will likely see any new construction in sight lines.

Slide 14: Shows Oakcliffe is zoned mixed use. Not a rezoning just a land proposal . Goal to provide housing options.
