Elena motions to write to letter in opposition of closing Zulema St. 2nd by Howard. Ron and Joann Cohen vote against writing opposition letter and are in favor of possible street closure. Rest in favor of writing opposition letter and against possible street closure.

Round Robin Questions/Concerns

Ron – City tax revenues contribute to decisions to open or close roads. Ex. adding height to a building will add revenue for city. Closing Zulema Street will add buildings and revenue. Possibly direct traffic under building to avoid closure?

Howard – Houses backing Zulema. Walnut Capital is preparing to demolish. PITT will then take ownership of property. Currently no plans for development. Will go through community process when time is right. Demo to start in August. Anticipate work to take about 3 weeks. Will not be closing Bates.

Mrs. Cohen - Questioned process by which OPDC was granted conservatorship of Niagara St house and was referred to contact Wanda Wilson at OPDC. A resident expressed concern that CHS residents are entering the property.
