### Minutes

Minutes of the October 13, 2021 meeting were approved. Howard Stevens motioned. Joan Dickerson 2<sup>nd</sup>. Unanimous approved.

### **Residential Parking Permit program.**

Director of City Planning, Andrew Dash will be present to discuss Ordinance 2021-1867, which would amend the Residential Parking Permit program. Changes include Dept of City Planning no longer being involved in making regulations and setting policy, unclear roles of Parking Authority and Dept of Mobility and Infrastructure in making regulations and setting policy, developing hybrid districts, and new non-resident permit types for landlords, contractors, medical care workers, and childcare providers.

RPP and changes – Code has not been changed since start of program.

New types of permits:

People were asking for variances. Decided to make it formal. Create new nonresident permits. Ex. medical caretakers, child care providers such as nannies, contractors (who will be working at an address for an extended period of time), landlords for properties they own and maintain within RPP area.

## Hybrid residential parking areas

Proposed for areas near a large institution or stadium. Many areas in Oakland fall under. Instead of a grace period where they park for free would be able to pay at a meter. Student with one class, someone running errands. Would mean no grace period at all. Would have people pay by the app. Would not be putting physical parking meters in residential neighborhoods. If you currently have a one hour grace period, someone would be allowed to pay.

Progressive pay structure - Homes that have multiple cars. Try to discourage them from all parking in the area. Would become progressively more expensive for the number of cars that a resident tries to register.

## **Questions:**

Enforcement: Done through Pittsburgh Parking Authority. Hope by clarifying RPP will make it easier to enforce. Pittsburgh Parking Authority will be responsible for enforcement.

Possibility of citizens' enforcement? Such as allowing citizens to request enforcement at particular times of day. – This will be up to Parking Authority.

Stickers allowed us to monitor. Now we can tell and ask for more enforcement. – Residents can call with licenses plates. Not sure how effective this is.

Higher fines might discourage illegal parking. Getting a ticket occasionally is cheaper than finding parking elsewhere.

What would people without a phone do to pay without kiokisks?

Southside gets enforcement but Oakland never gets enforced its full hours enforced.

Any thoughts to table until there is a budget? Decision is City Council. However current system is harder to enforce.

## **Oakland Transportation Management Association** – Mavis

The legislation would offer Americans a refundable tax credit worth 30 percent of a new e-bike's purchase price, capped at \$1,500. All three e-bike classes would be eligible for the tax credit, but bikes with motors more powerful than 750W would not. The credit would be fully refundable, which would allow lower-income individuals to claim it. E-bikes are significantly more expensive than normal bikes, typically costing anywhere from \$1,000 to \$8,000. But they also have the potential to replace car trips for a lot of people, which could help make real progress in the fight against climate change. A recent study found that if 15 percent of car trips were made by e-bike, carbon emissions would drop by 12 percent.
