- a. Neighborhood Plan for Oakland

- b. Walnut Capital's Oakland Crossings Zoning Ordinance #2021-1906 Planning Commission has made a recommendation to City Council to adopt with some recommendations. The project should start construction mid to late June and should be completed in the fall, most likely end of October.

- <u>e.</u> **3221 Kennett St** Won appeal in the Court of Common Pleas to have it remain a single family dwelling. Decision is not being appealed.
