- c. Neighborhood Plan for Oakland

- **d. Oakcliffe Greenway -** \$200,000 has been allotted for the Oakcliffe Greenway project from the Capital Budget. Our priorities as determined at our June meeting have been sent to Councilman Kraus.
 - Bob Charland Confirmed that project is going to DOMI. Pleased to see plans were usable and professional something to work from.

- DPW will be helping but project will be headed by DOMI.
- Letters of support helpful to get project moving.
- Separated in two parts Overlook and lower trail. Overlook to be addressed first.

e. Quality of Life Ticketing
