# Oakcliffe Community Organization Meeting Minutes- Wednesday, January 10, 2024

#### **Opening**

#### **Old Business**

#### a. Lindy Paving

The following report from Christine Graziano was read.

- The ACHD has not issued a final permit yet.
- Two distinct emissions events were observed and recorded and sent to the ACHD in December.
- The Options Document is complete and under review by Christine and Elena. The ad hoc committee needs
  to be formed before it can be reviewed by others. There is a public-facing summary of the document under
  development. We are aiming for the ad hoc committee to meet later in the day during the week at least
  every other week or as needed to move things forward. We will strategize on incorporating the wider and
  widening community during those meetings.
- Elena and Christine met with Breathe Project Exec Dir in December, and will be continuing the conversation; Breathe Project are supportive of this effort and willing to help us seek future funding for related needs.
- Randy from CREATELab expects to have the camera up by the end of January; new technology being used is taking longer than expected.
- A new position has been named at the City- Sustainable Procurements- and Erika Strassburger has connected us to her so that the warm mix specification change can be written into new rules. That seems positively to bemoving forward. If you can write to your Council rep in support of this change that would be great.
- Funding has not yet been released for EPA funded sampling and monitors. However, Christine took an air sample for lab analysis and those results are back and being reviewed. It appears a variety of compounds were flagged as being over expected limits.
- Lindy Paving's President is on the Innamorato Transition Team. It is important to utilize their survey to ask them to consider our concerns, meet with the community (Lindy and Admin) and to push for a stricter permit per our requests. In addition, utilize this survey to request that the County specifies warm mix asphalt in their contracts and projects. <a href="https://www.alleghenyforall.com/community-survey">https://www.alleghenyforall.com/community-survey</a>

Comments need to be sent to Air Quality Permits <aqpermits@alleghenycounty.us> by Jan 23.

We have the permit documents available for review and Clean Air Council's attorney is reviewing them. It would likely be important for all interested in this section of the riverfront and air quality from there to be ready to speak and/or submit comments. Some emissions and odors have been detected there, although we aren't as informed as with Lindy. It is important to show we are paying attention at a minimum. Please stay tuned for 'talking points' for comments and speaking, which will be circulated in the coming week.
